


"Huh?"

"Is it true? I'm curious...


"It's like you can predict the future."

Sean did not expect Jenson to come to him when he had no idea what to do.


Sean would be a fool if he did not take this chance.

Kyle gnashed his teeth and spat out a mouthful of blood, still in denial.


He was even considering hiring another group of people to go after Sean.


"What we're afraid of?

Willow realized that too.






When Willow spoke earnestly again when Sean was silent.

'But Old Madam Quinn said Reach For Will Group held me in high regard.


'It belongs to me. So why did she say that?"


Sean was unsure if Old Madam Quinn was testing him or if she was up to something else.

"It's because I love her that I want more for her.


"Should I expect you to be merciful and give her anything?"

The more Willow thought about it, the more unbelievable it sounded. 5



"Everything's fine as long as you know what to do. I'll report to you as soon as I know anything."


Jason hurriedly finished speaking and hung up.

After all, Blaze knew how terrifying Sean could be in his prime.




